UNDERSTANDING OF CODE OF CONDUCT

During the time spent at the St. John's sponsored youth activity, I will have a *positive attitude* and participate in all scheduled programs. I realize that the following are NOT permitted: possession/consumption of alcohol or illegal drugs, tobacco or tobacco products (including electronic products); possession of any weapons; inappropriate language; willful destruction of property; boys in girls' lodging areas; girls in boys' lodging areas; violation of established curfew; youth driving to out-of-town events; other conduct as determined inappropriate by youth advisors. I am aware of the following steps, should a violation occur: (1) Youth Advisor(s) will discuss the concern with the youth. (2) Youth Advisor(s) may request that a contact be made to the youth's parents to make the parents aware of the situation. The Youth may be present at the time of the contact. (3) The Youth Advisor(s) may request the parents arrange transportation home for the youth.
