Submit completed contract with a \$50 **non-refundable** reservation fee to the church office. A copy will be returned to you upon confirmation. The balance of the rental fee must be paid in full one week prior to arrival date. A minimum of a 30-day notice is requested for cancellation. Camp keys may be obtained by contacting the church office prior to arrival date. (717-263-8593)

CAMP REGULATIONS

- The following are prohibited:
 - Motorcycles/ATVs and dogs
 - Drugs - Violators will be evicted.
 - NO display of alcoholic beverages.
 - Cutting or removal of live trees/plants from the property
- Groups are restricted to 50 people.
- Campfires** are *only* permitted in designated areas, should not be left unattended, and should be properly/completely distinguished after use.
- Groups must furnish their own supplies (toilet tissue, paper towels, napkins, trash bags, etc.)
- The designated group leader is responsible for all activities on the camp property and are responsible for any damages that occur.
- The designated group leader is responsible for any long-distance phone calls.
- Parking permitted *only* in designated areas.
- St. John's United Church of Christ does NOT provide medical insurance for organizations renting the camp.

PROCEDURES UPON ARRIVAL:

- Unlock only the buildings being used.

PROCEDURES BEFORE DEPARTURE:

- Gather trash in and around the buildings and place in proper receptacles.
- Sweep all occupied buildings, including restrooms.
- Check that all campfires have been completely distinguished.
- Turn off all lights and secure **ALL** buildings – close all windows and lock all doors.
